#### **Public Comments:**

Councilman Redick read the following letter received from Jim and Barb Cudney:

"In regard to the Town Law on dog licensing; although I do not at this time harbor a dog, I have certainly had many dogs in my lifetime. I feel that special attention should be paid to seniors (over 65) that license dogs. Perhaps a senior license rate? Pets are very important companions for the elderly. I also feel that guide and service dogs should be free of license fees of all kind.

In reading proposed and adopted Dog Control Laws from several towns in our county and also Monroe County, I have noticed special circumstances for guide and service dogs and also senior citizen's dog license fees.

In any case, I feel that the fees collected from dog owners should be adequate to cover all the expenses involved for the Town to manage the dog control. A break-even situation would be fine. I do not see any need to subsidize dog control with tax money from the general fund budget. Dog ownership is a long-term responsibility that should be the responsibility of the dog owners only."

WHEREAS, pursuant to Part 617 of the implementing regulations pertaining to Article 8 State Environmental Quality Review Act (SEQRA) it has been determined by the Town Board of said Town that adoption of said proposed Local Law would not have a significant effect upon the environment and could be processed by other applicable governmental agencies without further regard to SEQRA, and

**WHEREAS,** the Town Board of the Town of Byron, after due deliberation, finds it in the best interest of said Town to adopt said Local Law.

**NOW, THEREFORE, BE IT RESOLVED,** that the Town Board of the Town of Byron hereby adopts said Local Law entitled The Town of Byron Dog Control Law, a copy of which is attached hereto and made a part of this resolution, and be it further

**RESOLVED,** that the Town Clerk be and she hereby is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of Byron, and to give due notice of the adoption of said Local Law to the Secretary of State of New York.

Neutered Male or Spayed Female:	\$ 8.00*

\* which fees include the assessment of a \$3.00 surcharge for the purpose of carrying out animal population control for unneutered male and unsprayed female dogs, and the assessment of a \$1.00 surcharge for the purpose of carrying out animal population control for neutered male and spayed female dogs.

Purebred Licenses:	30.00 - No more than 10 dogs
	\$60.00 – 11-25 dogs
	\$110.00 – More than 25 dogs

Plus an assessment of a \$3.00 per dog surcharge for the purpose of carrying out animal population control for unneutered male and unsprayed female dogs, and the assessment of a \$1.00 per dog surcharge for the purpose of carrying out animal population control for neutered male and spayed female dogs.

Late Fee (assessed after 60 days of non-payment): \$5.00 Enumeration Fee: \$5.00 Replacement Tag: \$3.00
