Effective February 22, 2010, all residences, both new and existing, will be required to have carbon monoxide alarms installed. The specific requirements differ for new and existing residences and also on when the buildings were built and subcategories of occupancy groups. In existing one and two family residences, one carbon monoxide alarm will be required to be installed on the lowest story having a sleeping area.

#### WATER DISTRICTS:

#### WATER DISTRICT NO. 2 GAGAS AUDIT:

·If the federal assistance expended was less than \$500,000 for the fiscal year and the municipality has a Rural Development debt of \$1 million or more an audit shall be submitted on an annual basis in accordance with "Generally Accepted Government Auditing Standards" (GAGAS). GAGAS audits will only need to cover the specific fund which involves federal financial assistance (currently Water District Nos. 1 and 2). The GAGAS audit needs to be submitted no later than 150 days after the end of the fiscal year. Freed Maxick has sent an Engagement Letter for their services with the GAGAS audit to be done at a cost of approximately \$3,100.

## 2009 WATER DISTRICT NO. 1 AND 2 GAGAS AUDIT

### **RESOLUTION #44:**

Councilwoman Freeman offered the following resolution and moved for its adoption: *RESOLVED:* That the Byron Town Board authorizes Robert Crnkovich, Town of Byron Supervisor, to execute an engagement letter for the 2009 GAGAS Audit to be prepared by Freed Maxick & Battaglia, P.C., at a cost of \$3,100.00.

### **WATER DISTRICT NOS. 3 & 4:**

•Per the Town Attorney there are additional steps that need to be taken to meet Comptroller approval. The Comptroller's Office is requiring a Petition signed by 51% of the residents of Cockram Road West, or 51% of the assessed value, approving the increase in amount to be expended. Once the Town Clerk has received the completed petition a special meeting with need to be called in order to call a Public Hearing.

## **WATER DISTRICT NO. 4 EASEMENTS**

## **RESOLUTION #45:**

Councilman Thompson offered the following resolution and moved for its adoption: **WHEREAS**, Water District No. 4 (the "District"), located in the Town of Byron, Genesee County, New York, intends to construct a water main (the "Project") to bring the Monroe County Water Authority's (the "Water Authority") supply to the property owners of the District; and

**WHEREAS**, the acquisition of three (3) easements by the Water Authority that are located along the Project is necessary for the construction, installation, operation and maintenance of the Project; and

**WHEREAS,** the acquisitions are necessary to allow the completion of the Project which will provide potable water supply and fire protection to the District's property owners; and

**WHEREAS,** Section 1096(6-a) of the New York Public Authorities Law requires the Water Authority to obtain the prior approval of the above-referenced acquisitions by resolution of the Town Board of the Town of Byron, New York.

### **NOW THEREFORE,** be it

**RESOLVED,** that the Town Board of the Town of Byron, New York, hereby approves of the above-described acquisition in accordance with Section 1096(6-a) of the New York Public Authorities Law.

## WATER DISTRICT NOS. 3 & 4 BID ACCEPTANCE RESOLUTION #46:

Councilwoman Freeman offered the following resolution and moved for its adoption: *RESOLVED:* That the bid of Mar-Wal Construction Co., Inc. for Two Hundred Nineteen Thousand Eight Hundred Fifty Dollars (\$219,850.00) to construct the water main,

hydrants and other necessary structures in Water District No. 3 (Ivison Road) and Water District No. 4 (Cockram Road) is hereby accepted, subject to and contingent upon the Districts receiving permission to increase the maximum amount to be expended from the Office of the New York State Comptroller.

Councilman Thompson seconded the resolution which was adopted by the following vote:

### WATER DISTRICT NO. 5 (Cockram Road East):

- ·Received PED from Rural Development
- ·Cost would be \$189,000, which would consist of a grant for \$84,000 (can only be 45% of the cost of district) and a loan for \$105,000 at an interest rate of 3.25%.
- ·Charge of \$1,232/yr. includes debt service and water usage for 38 years. Based on \$270/yr. water usage cost
- ·Comptroller limit is currently \$677, so the district would need to be approved by the Comptroller.
- ·It was decided that the residents of Cockram Road East would contact the Supervisor with their decisions before the next board meeting.

## WATER DISTRICT NO. 6 (Pumpkin Hill):

·Town of Bergen recently had a meeting of their residents. Eric Wies believes the district needs to at least include Sautell Road in order to get approval from MCWA. Of the people they asked, 53% were in favor of public water, 39% were not interested, and the remaining were undecided. However, only 36 of the 98 units responded to the survey. The Town of Bergen will be contacting residents to get an informal vote.

### **WATER DISTRICT NO. 7 (Lyman, Freeman and Coward Roads)**

- •Clark Patterson did a cost summary with and without the Town of Bergen. The cost estimate is in the \$950 range
  - •Do not really need to have Bergen involved to have this district
- •The main on West Bergen Road would be the property of Byron if Bergen did not decide to go in with Byron at the time the district was formed.
  - •Next step would be to have an informational meeting to discuss cost with residents.

### **WATER DISTRICT NO. 8 (Swamp and Hessenthaler Roads):**

- ·Received petition for Swamp and Hessenthaler Roads.
- •The next step would be to invite residents to a meeting and give them best guess of what it will cost, and find out if they would like to move forward.
