roll for State certification for annual aid and CAP aid. It appears that payment to the Town of 2009 aid will happen in March of 2010. 2008 aid was received in March of 2009. Totals are as follows:

In the past, I have spread the cost of training around to each town so that each town generally paid once every three years. With reimbursement taking so long to come back to the towns, this is now becoming harder to be fair to each town. I used Byron in 2008 and the money came back in 2009 so we are actually a little ahead here. I am now going to run all my training expenses through the Town of Oakfield. Once the training is done and the amount of State reimbursement is determined, I will create a voucher showing the total cost minus state reimbursement for a total that will then be divided by 3, and each town will pay their share. The total cost of training in each town budget will not be increasing, just how the payments are made.

A RESOLUTION AUTHORIZING THE ISSUANCE OF \$143,000 SERIAL BONDS OF THE TOWN OF BYRON, GENESEE COUNTY, NEW YORK, TO PAY THE COST OF THE CONSTRUCTION OF A WATER SYSTEM TO SERVE WATER DISTRICT NO. 3 IN SAID TOWN.

WHEREAS, pursuant to proceedings heretofore had and taken in accordance with the provisions of Article 12 of the Town Law, the Town Board of the Town of Byron, Genesee County, New York, has established Water District No. 3 in the Town of Byron; and

WHEREAS, the improvements for said Water District No. 3 shall consist of the construction of a water system to serve said District, including water mains, distribution pipes and hydrants, as well as the acquisition of land and rights-in-land, and incidental costs in connection therewith, as more fully described in the map, plan and report prepared in connection with said Ivison Road Water District No. 3; and

WHEREAS, the maximum amount proposed to be expended for said improvements is \$143,000; and

WHEREAS, said capital project has been determined to be an Unlisted Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, the implementation of which as proposed, the Town Board has determined will not result in any significant environmental effects; and

WHEREAS, it is now desired to authorize the financing of said improvements; NOW, THEREFORE, BE IT

RESOLVED, by the Town Board of the Town of Byron, Genesee County, New York, as follows:

<u>Section 1.</u> For the specific object or purpose of paying the cost of improvements in connection with the construction of a water system to serve said District, including water mains, distribution pipes and hydrants, as well as the acquisition of land and rights-in-land and incidental costs in connection therewith, as described in the preambles hereof, there are hereby authorized to be issued \$143,000 serial bonds of the Town of Byron, Genesee County, New York pursuant to the provisions of the Local Finance Law.

<u>Section 2.</u> It is hereby determined that the maximum estimated cost of the afore described improvements is \$143,000 and that the plan for the financing thereof shall consist of the issuance of the \$143,000 serial bonds of said Town authorized to be issued pursuant to this bond resolution.

<u>Section 3.</u> It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is forty years, pursuant to subdivision 1 of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will exceed five years.

<u>Section 4.</u> Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Supervisor, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Supervisor, consistent with the provisions of the Local Finance Law.

Section 5. The faith and credit of said Town of Byron, Genesee County, New York, are hereby irrevocably pledged to the payment of the principal of and interest on such bonds as the same respectively become due and payable. There shall be annually assessed upon and collected from the several lots and parcels of land within said Water District No. 3 in the manner provided by law, an amount sufficient to pay the principal and interest on said bonds as the same become due, but if not paid from such source, all the taxable real property in said Town shall be subject to the levy of ad valorem taxes without limitation as to rate or amount sufficient to pay the principal of and interest on said bonds as the same shall become due.

<u>Section 6.</u> The powers and duties of advertising such bonds for sale, conducting the sale and awarding the bonds, are hereby delegated to the Supervisor, who shall advertise such bonds for sale, conduct the sale, and award the bonds in such manner as he shall deem best for the interests of the Town.

<u>Section 7.</u> All other matters, except as provided herein relating to such bonds, including determining whether to issue such bonds having substantially level or declining annual debt service and all matters related thereto shall be determined by the Supervisor.

<u>Section 8.</u> This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150 - 2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

Section 9. The validity of such bonds and bond anticipation notes may be contested only if:

- 1) Such obligations are authorized for an object or purpose for which said Town is not authorized to expend money, or

WHEREAS, said capital project has been determined to be an Unlisted Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, the implementation of which as proposed, the Town Board has determined will not result in any significant environmental effects; and

<u>Section 4.</u> Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Supervisor, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Supervisor, consistent with the provisions of the Local Finance Law.

Section 5.
