HIGHWAY SUPERINTENDENT'S REPORT – George Heins:

- •Received \$58,311.13 from Genesee County for salt and ice on County roads
- ·Grading and repairing Starowitz Road with the Town of Elba next week
- ·Assisting Stafford with stoning of roads
- ·Putting Memorial Day flags on poles
- ·Doing ditch work
- ·Received petitions back regarding resolution to keep Highway Superintendent and Town Clerk as elected positions instead of appointed. Most of the town boards in Genesee County have passed resolutions to support elected Highway Superintendents, Town Clerks and Tax Collectors.

A <u>motion</u> was made by Councilman Ivison to leave the offices of Highway Superintendent, Town Clerk and Tax Collector as elected positions unless altered by mandatory referendum. The motion was seconded by Councilwoman Freeman and carried with the following vote:

Councilman Ivison also stated that he wants to continue discussions with other towns on these options.

BUILDING COMMITTEE:

•Eric Wies was present to discuss three proposed changes to the highway garage

Option 1: Approximate cost would be \$553,000

·40 x 80 block addition to existing structure with two column supports

Option 2: Approximate cost would be \$316,000, with an additional \$34,000 for a break room

·50' x 80' new structure with new break room in the existing highway garage

Option 3: Approximate cost would be \$334,000, with an additional \$34,000 for a break room

 \cdot 50' x 80' addition to existing Morton building with a new break room in the existing highway garage

·All three options include ventilation systems.

·The Town Board will review these proposals and revisit this topic at the next meeting.

PESH REPORT:

•The Town was cited for two serious violations by the Department of Labor/PESH. These need to be remedied by June 17, 2009.

·Break room on second floor – Supervisor Felton would like to move the break room to Highway Superintendent's office, the Highway Superintendent to the sewer office, and the sewer office to an empty office in the main office area. The Highway Superintendent would like to move the break room down to the highway garage and share the Highway Superintendent's office.

Superintendent Heins: Moving the Highway Superintendent's office to the sewer office would not allow him access to the highway garage. He will remedy the break room situation prior to the next board meeting.

WATER DISTRICT NOS. 3 & 4:

•Continue to process paperwork. Seeking additional funds from Rural Development

A <u>motion</u> was made by Councilwoman Freeman to authorize Thomas Felton, Town of Byron Supervisor, to sign the amendment to the Municipal Solutions, Inc. contract for Water District Nos. 3 and 4, total fee for amendment not to exceed \$1,000 for each. WATER DISTRICT NOS. 5 & 6:

•An informational meeting was held on April 28, 2009 for residents of Water District No 5 and 6. Approximately 60 people attended. Cockram Road East (Water District No. 6) will also be moving forward also.

·Water District No. 5 has been increased to include property in Bergen. The Town of Byron would do an Intermunicipal Agreement with the Town of Bergen.

SLEDS OF STAFFORD LANDOWNER PERMISSION FORM:

 - ·Councilwoman Freeman will have more information at the next board meeting

LETTER OF SUPPORT FOR STAGGERED TERMS FOR GENESEE COUNTY LEGISLATURE:

·At present all terms expire simultaneously. There is concern that the whole legislature could be removed at one election.

·The County would like to have terms staggered to avoid this situation

A <u>motion</u> was made by Councilman Ferguson to support the Genesee County Legislature terms being staggered. The motion was seconded by Councilman Redick and carried with the following vote:

BYRON BERGEN PUBLIC LIBRARY/GILLAM GRANT LIBRARY:

•Both libraries are considering consolidating to reduce costs

·They are also considering creating a taxing entity in which the Town of Bergen and Town of Byron would be equally responsible for funding

PUBLIC COMMENTS:

Barb Emerson: Discussed the issue of four wheelers with loud mufflers creating enormous amounts of dust on West Shore Trail.

Councilman Ivison: The Highway Department could use brine, which is given to the Town for free, to keep dust down on the trail.

Randy Ridd: He would like the ditch cleaned out that runs along railroad bed that dumps water on his property and has caused a drainage issue.

Superintendent Heins: The Highway Department has tried to clean out the ditch, but it is a huge project. He will attempt to get to it.

Sue Fuller: She was told the Town can't help with culvert problems on private property. She is still upset about Code Enforcement Officer's remarks about gas grill on wood stairway. There has not been a gas grill on the wood stairway for months.
