### PLEDGE TO THE FLAG:

Supervisor Felton led the people in attendance in the Pledge of Allegiance.

# **PROPOSED 2010 TOWN OF BYRON BUDGET:**

•The Town Board discussed the Proposed 2010 Town of Byron General, Highway and Fire Department budgets. The following comments and inquiries were made:

## **General Fund Preliminary Budget:**

### A1420.4 (Attorney Contractual):

- ·Would like to allocate money for water districts. Money will come back to the town during construction.
- ·Supervisor Felton would recommend budgeting \$15,500 for general attorney fees, including Zoning Contingency, and a separate line item of \$44,000 for the Water Districts.

### **A3620.1** (Safety Inspection Personal Services):

- ·Increase 3% to \$18,077.
- •The Town Board would like to break the ZEO compensation out to a separate line item for additional ZEO responsibilities zoning enforcement.

# A7110.4PK (Park Program Contractual Expense):

•Reduced from \$3,000 to \$2,000 due to new restrictions

### A7110.4 (Park Program Contractual Expense):

·Would like to increase from \$\$2,000 to \$5,000 to budget money for Robins Brook Park for mowing, etc. at a cost of \$2,000.

### A7410.4 (Library):

- ·Byron Bergen Public Library is requesting \$12,400 for 2010
- •The Town Board would like to see this line item cut back to \$1,000 due to the closing of the Gillam-Grant Library.

# **A8010.1Z:** (Zoning Personal Services):

•The Town Board would like to include \$5,000 for zoning contingency if a Zoning Officer is hired or the current Zoning Officer does more zoning work

# **A8030.4** (Research Contractual Expense):

·Supervisor Felton would like to increase this line item to \$49,000 for water districts.

•The cost of the Income Eligibility Determinations for each water district is not able to be recouped by the town.

# A9010.8 (Employees NYS Retirement):

·Increase to \$15,000 due to 2010 projection

### A9901.9 (Interfund Transfer to Highway Fund):

•\$25,000 from general to highway historically, but will not be doing this for 2010.

### **Highway Fund Preliminary Budget:**

## DA5110.1 (General Repairs Personal Services):

•The Highway Superintendent has requested \$78,000 for 2010. Historically, this figure has been less than \$70,000.

# **DA5110.4** (General Repairs Contractual Expense):

•The Highway Superintendent has requested \$125,000. Historically, this figure has been approximately \$100,000 (combined with CHIPS money = \$150,000.

### **DA5142.1** (Snow Removal Personal Service):

•The Highway Superintendent has requested \$120,000. Historically, this figure has been approximately \$112,500.

### **DA5142.4** (Snow Removal Contractual Expense):

•The Town Board would like to reduce this figure from \$115,000 to \$105,000 due to figure historically being approximately \$110,000

#### **Calculating Tax Rate:**

Assessment: \$96,637,740

·If the Town maintains the same tax rate as 2009 (\$1.93/thousand) it will generate \$186,510.

•For comparison, the Town's assessment was \$95,911,437 for the 2009 budget, and \$185,109 was received in property tax revenue.

### **Fire Department Budgets:**

•The Town Board would consider increasing funding based on certain requirements – receipt of certifications.

·Supervisor Felton will ask the fire departments to come to the October 29<sup>th</sup> meeting.
