#### **MINUTES:**

#### **HIGHWAY SUPERINTENDENT'S REPORT – George Heins:**

•The Highway Superintendent believes the year end financial statements are not correct

There has been no sales tax deposited into the Highway Fund in 2009

•There has been no town tax monies deposited into the Highway Fund so far in 2009

•CD deposited for 1 year of reserve. The Highway Superintendent thought he would do it for 3-6 months if loader is purchased, but now it's tied up. A loader would cost approximately \$130,000 - \$175,000. The Town's current loader is worth approximately \$50,000 - \$55,000.

•Truck replacement: 4% for 5 years, \$107,000 plus January 2010 emissions will increase about 6% plus \$70,000 plow equipment.

•The Highway Superintendent would also ask the Town Board write a letter to our State Legislators to support more funding for CHIPS Program in highways.

•CHIPS money to decrease from \$74,647 to \$42,561 for 2009.

#### **Building Committee:**

• Supervisor Felton and Councilman Ivison met with Eric Wies regarding Clark Patterson helping to come up with a viable option for the highway garage. Clark Patterson would be willing to look at highway garage, but it would come at some cost. Supervisor Felton would like to get together with Superintendent Heins and Councilman Ferguson to discuss their options before moving forward.

# **RESOLUTION #33:**

**BE IT ENACTED**, that the Byron Town Board, on behalf of the Byron Sewer District, hereby amends Section 113 of the Sewer District Ordinance to increase the interest rate charge for delinquent payment of sewer bills from one and forty-eight hundreths percentum (1.48%) per month, to ten percentum (10%) per quarter. Section 114 shall be amended by authorizing the Town Board to amend, change, alter or otherwise adjust any and all fees, charges, taxes, or any other levies contained in the Sewer Ordinance by formal resolution adopted by a majority of said Board.

# PAYMENT OF WATER DISTRICT NO. 2 ABSTRACT #1

#### **RESOLUTION #36:**

Councilman Ferguson offered the following resolution and moved for its adoption:

*Resolved,* that the Byron Town Board agrees to pay Water District No. 2 Abstract #1 in the amount of \$6,400.00 to Randsco Pipeline (\$5,000) and Clark Patterson Associates (\$1,400), subject to the approval of Rural Development.

**WATER DISTRICT NOS. 3 & 4** – received approval from Comptroller and the Town is now moving forward

**WATER DISTRICT NO. 5** – Eric Toal is finishing getting responses from residents who have not responded to the Town's straw poll. Approximately \$2.5 million of assessed value would like to have water. About \$1.7 million of appraised value does not want water. There is approximately \$1 million of assessed value that has not responded, and this will determine if the water district will be going forward.

**Supervisor Felton:** Spoke with Eric Wies regarding Water District on Cockram Road East, and he believes this may be a fundable water district.

#### **TRANSFER STATION:**

**Councilman Ferguson:** Concerned about vehicles going back to transfer station during the day.

**Superintendent Heins:** Most people are bringing in recyclables during the week **Supervisor Felton:** There was a shortfall of approximately \$1,600 in 2008 **Superintendent Heins:** He does not believe that is correct because a load of tires

with a cost of \$1,500 was also included in that amount in 2008.

#### **AUDIT:**

Councilwoman Freeman and Councilman Ferguson reviewed the Town Clerk, Bookkeeper and Justice accounts.

**Councilwoman Freeman:** She has contacted Marilyn Weinert to serve on the Water Committee, and she has accepted.

#### **PUBLIC COMMENTS:**

**Councilwoman Freeman:** She is still getting signatures on petition for proposed Hessenthaler and Swamp Road water district.

# **SUPERVISOR'S REPORT:**

•Received 4<sup>th</sup> quarter sales tax check for 2008 in the amount of \$149,882.65 •Training classes will be coming up for the Town Board and Planning Board •Receiving monthly instead of yearly bills from Boylans •Next GAM meeting will be February 19<sup>th</sup>

•Genesee County Youth Bureau funding will be decreased, or possibly eliminated, and summer youth program may be cancelled

•Supervisor Felton has asked Nancy Bailey from the Byron-Bergen Library for information on usage by Town of Byron residents.

•At last month's Town Board meeting, a fireman who was in the audience asked if the Town had heard about a new law that permits the Town Board to provide health insurance to volunteer firefighters and volunteer ambulance workers at the individual volunteer's cost. Upon investigation, this is a new law that went into effect on January 17, 2009

•November 19<sup>th</sup> Byron will be hosting GAM meeting
